**Call for Participants International Summer School “The roots of the European legal culture. Ancient texts and documents between language and law” (Naples, 18th-24th September, 2017).**

### **Object**

The Vincenzo Arangio-Ruiz Interdepartmental Centre for Historical and Legal Studies on the Ancient World (Naples, Cortile del Salvatore, via Paladino, 39 - via Mezzocannone,8) organizes the International Summer School “The roots of the European legal culture. Ancient texts and documents between language and law”, in collaboration with the “Gérard Boulvert Inter-University Consortium for studies on the European legal civilization and the history of its systems” as well as with the “Centre for Roman cultural law and contemporary legal systems” of the Magna Graecia University of Catanzaro. The promoting, scientific and organizing committee is made up of Professors Carla Masi Doria, Cosimo Cascione, Giovanna Daniela Merola, Isabella Piro, Francesca Reduzzi and Annamaria Salomone.

### **Aims**

The Summer School aims at increasing the skills of university students, PhD students, research assistants, public employees and young professionals on the historical-legal basis of Europe through an innovative higher education model, i.e. the relationship between language and law, which must be further experimented in internationally relevant training. The Roman legal experience has determined and influences the present. To fully understand this journey through time, documents are decidedly precious. These sources inform us on the Roman legal procedure and its versatile variety. The existence in Campania of an extraordinary patrimony of documentary archives explains the choice of setting up in Naples a Summer School, open to participants from all Europe and the other continents. The participants will be able to directly examine this documentation, to study its contents and to compare it to the patrimony coming from other parts of the Mediterranean area.

### **Summer School sessions**

The Summer School sessions will take place between 18<sup>th</sup>-24<sup>th</sup> September, 2017, during the morning and the afternoon. Academic sessions will be held in classrooms, while practical sessions will be held *in situ* (in prestigious archaeological and archive/library institutions), according to the program here attached (**attachment 1**).

The lectures will be held both in English and in Italian.

Attendance is compulsory.

### **Eligibility criteria**

The Summer School is open to PhD/ doctorate students, students attending higher education courses, students who have been awarded a grant, research assistants and young professionals. Recent graduates (five-year degree courses) in fields relating to the Course topics may also apply, as well as students enrolled from the fourth year onwards of their studies, and students attending the two-year period of the second cycle academic degree.

### **Auditors**

Applicants without the necessary qualifications may forward their application to take part in the course as auditors. The Selection Board reserves the right to select the auditors on the basis of the motivations presented.

### **Application**

Applicants should fill in the form available at the Arangio-Ruiz Centre web address (**attachment 2**). The form must be addressed to the Director of the Arangio-Ruiz Centre and must be sent, by e-mail only, to the [centro-arangio-ruiz@unina.it](mailto:centro-arangio-ruiz@unina.it) address and forwarded to the centre's administrative secretary's office, Dr. Diana Colaianni at [dcolaian@unina.it](mailto:dcolaian@unina.it).

The application must be accompanied by the following documentation:

- *curriculum vitae*;
- any other documentation considered useful to be accepted;
- for students without a degree, an equivalent declaration or a certificate of exams complete with the marks obtained.

**The Application must be presented from 28<sup>th</sup> April to 28<sup>th</sup> June, 2017**

Any applications received after this date will not be taken into consideration.

Maximum number of participants: **thirty**.

The Summer School will be activated with a minimum of **8 participants**.

### **Selection**

The selection will be based on the *curriculum* of the candidates.

The Selection Board will be made up of the members of the organizing Committee.

The list of the admitted applicants will be published on-line at <http://www.centroarangio-ruiz.unina.it/> and on the University of Naples, Federico II site ([www.unina.it](http://www.unina.it)) by **7<sup>th</sup> July, 2017**.

### **Diploma**

The participants who will have attended assiduously and profitably the courses and the activities of the Summer School will receive a Diploma.

Students who are enrolled in a Law Degree Course at the University of Naples Federico II, and at the University Magna Graecia of Catanzaro, will receive 3 CFU for extra-curricular activities as set by the university course requirements.

### **Enrolment Fee**

The enrolment fee is 250 Euros and includes:

- academic activities;
- cultural activities;
- guided visits (The Archaeological Museum of Naples, the excavations in Pompeii, the Campi Flegrei);
- lunch (from 18.09 to 24.09), the Course welcome dinner as well as the farewell dinner;
- any transfers necessary to take part in the Summer School's didactic and cultural activities;
- a Diploma indicating their participation in the course.

### **Contributions**

The organizing Institutions offer participants, to refund expenses which can be justified, up to a maximum of 6 contributions: 3 contributions up to a maximum of 500 Euros for European applicants and 3 contributions up to a maximum of 1,000 Euros for non-European applicants. The contributions will be

assigned by the Selection Board to the requesting applicants on the basis of a comparative evaluation of their *curricula*.

#### **Methods of Payment**

- an initial fee of **100 Euros** must be paid within a fortnight from the admission to the Summer School (from the publication of the results)

- the balance can be paid on-line (with a bank credit transfer) by 10<sup>th</sup> September or at the head office when the Course starts.

Both the payments for the initial fee and the balance must be made with a bank credit transfer at the following Iban: **IT86F0101003593100000301512** indicating as the reason for payment respectively initial fee/balance for the Arangio-Ruiz Centre Summer School.

#### **Renunciations and Refunding**

The publication of the results serves as official communication. The suitable admitted applicants who intend to decline should send a written declaration within a fortnight from the publication of the results.

If an admitted applicant declines, a suitable applicant according to the order of the published list will take his place. The latter will be contacted via e-mail.

Admitted applicants who decline after the deadline will not be refunded. Participants who interrupt the frequency of the courses will not be refunded.

#### **Personal Data**

The personal data provided by the candidates will be handled with by the Director of the Arangio-Ruiz Centre according to Law no. 96/2003 and any following modifications, for what concerns the completion of the selection procedure here described. The person responsible for the treatment of personal data is Prof. Carla Masi Doria, the Director of the Arangio-Ruiz Centre.

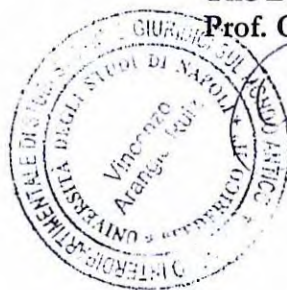
